Diplomat	<ul> <li>Packing lists in English.</li> <li>Passport copy.</li> <li>PRO6 (diplomatic exemption).</li> <li>1 x original Bill of lading (OR express release) / AWB / Road Consignment Note (RCN).</li> </ul>	<ul> <li>In order to process the exemption for diplomatic shipments by road, a road consignment note and packing list will be required.</li> <li>The shipper must be present at arrival of the shipment and must be in possession of his work permit in case of non-diplomats.</li> </ul>	<ul> <li>Inventory in English dated and signed by the shipper.</li> <li>For all 1st arrivals by air, the destination agent will need shippers' original passport (with entry stamp).</li> </ul>

		<ul> <li>Documents are to be express mailed 30 days before arrival of the shipment, in order for the shipper's employer to apply for the duty exemption.</li> </ul>	
General Information		<ul> <li>Consumables are not considered as used personal effects and are subjected to duties &amp; taxes.</li> <li>Non-diplomatic shippers will have to pay duties and taxes on all new items (Import duty 25% of CIF + VAT 18% of CIF +Railway Development Levy (RDL) 1.5% and Customs Processing Fees 0.6% of CIF on CIF)</li> <li>All imports should arrive in the country after the importer has acquired a work permit from the immigration. Customs allows you three months in which to import your used personal effects after arrival.</li> <li>Shippers' owned containers will be dutiable.</li> </ul>
