The TR gives an automatic Duty free allowance of \$2500 assessed on your goods.</li> <li>▪ The TR form is signed by the customer at destination.</li> <li>▪ The transfer of residence also includes foreign nationals coming to Pakistan for a period of two years or more.</li> <li>▪ Following items are allowed on the payment of 25% to 50% duties/taxes as notified from time to time by the federal government. Hence almost all if not all diplomatic shipments incur Port / Airport Storage Demurrage and container detention costs. Ask your local partner to</li> </ul>
